WHAT YOU CAN DO IF YOU SOLD A CAR BUT THE BUYER DIDN'T TRANSFER THE TITLE FACT SHEET Reporting a sale of a car is not the same thing as transferring the title to the car. The seller of a car is required to report the sale, and the buyer is required to transfer the title.

Chapter 2 Record Keeping Requirements - Michigan

A dealer must maintain records for each vehicle that is bought, sold, leased, or exchanged by the dealer or received or accepted by the dealer for sale, lease, or exchange. Records must be available for inspection by law enforcement and Michigan Department of State investigative staff upon request. 2-12 Record Retention
